DAY 1 Sunday, December 8: Depart for Ireland

Depart Houston Intercontinental Airport via United Airlines to Dublin, Ireland. Complimentary dinner (D), breakfast (B), and beverages will be served in flight.

DAY 2 Monday, December 9: Arrive in Dublin | Clonmacnoise | <u>Galway</u>

Arrive at Dublin Airport, proceed through Passport Control, claim our luggage, and meet a Peter's Way tour manager/guide as we exit Customs. Board our private coach, and we will be on our way to Clonmacnoise. Independent lunch en route.

Visit Clonmacnoise, located at an ancient crossroads where the Esker Way and the River Shannon meet. Clonmacnoise was a monastery founded by St. Ciaran in the 6th century, a place of religious learning and of pilgrimage, renowned for its literary and artistic achievements that enjoyed the patronage of Kings and Chieftains. It was home to three exceptional high crosses, a cathedral, seven churches, and two round towers. Celebrate Mass at the Shrine. After Mass, continue to Galway, the capital of the west, affectionately known as "The City of the Tribes." Check-in at our hotel in Galway.

(B D) Dinner and overnight at our hotel in Galway.

DAY 3 Tuesday, December 10: Kylemore Abbey | Cong | Galway Christmas Market

Irish breakfast at our hotel. Celebrate Mass (location to be advised). This morning, we'll leave on our excursion to visit Kylemore Abbey, a Gothic-style castle built in the 19th century by Mr. Heny, a rich Liverpool merchant, which today belongs to the Benedictine Nuns. Impressive, hidden between mountains and a lake and surrounded by rhododendrons, the Abbey is situated in a romantic place of great beauty. The entrance hall and three other rooms are open to the public. Restored by the nuns in a major restoration project, it can be described as a "cathedral in miniature" and is very faithful to the so-called decorated style church. Independent lunch.

On our return to Galway, we will stop in Cong, a small village that is known worldwide as the place where The Quiet Man was filmed, starring John Wayne and Maureen O'Hara. This evening, enjoy free time to visit the Galway Christmas Market. Independent dinner. (B)

Overnight at our hotel in Galway.

DAY 4 Wednesday, December 11: Ballintubber Abbey | Knock **Shrine**

Irish breakfast at our hotel. This morning, we'll leave on our excursion to visit Ballintubber Abbey, where Mass has been celebrated without interruption for over 800 years. Ballintubber Abbey is associated with St. Patrick because it gets its name "Baile Tobair Phadraig" from a nearby holy well dedicated to Ireland's national apostle. It was a beginning and ending point for pilgrims traveling the old pilgrimage road to Croagh Patrick. The abbey is dedicated to St. Patrick, the Virgin Mary, and St. John the Apostle. After our visit we'll continue to the National Marian Shrine of Knock. Independent lunch upon arrival.

We'll visit Ireland's National Marian Shrine in Knock. The story of Knock began on the evening of August 21, 1879, when the Virgin Mary, St. Joseph, and St. John the Evangelist appeared at the south gable of the church at Knock. Beside them was an altar with a cross and the figure of a lamb, around which angels hovered. There were fifteen official witnesses to the apparition who watched and prayed for two hours in the pouring rain. The special message of Knock is the need for penance.

Celebrate Mass at the Apparition Chapel at Knock Shrine (subject to confirmation). Late afternoon, return to Galway (B,D)

Dinner and overnight at our hotel in Galway.

DAY 5 Thursday, December 12: Burren Region | Cliffs of Moher | **Killarney**

Irish breakfast at hotel. This morning, we will celebrate Mass at Galway Cathedral (The Cathedral of Our Lady Assumed into Heaven and St Nicholas). After Mass we will drive through the most spectacular Burren Region. "Boirean" is Irish for "rocky." The region got its name from its polished limestone landscape, a glaciokarstic plateau with porous carboniferous limestone and shale systems. It is hard to believe that it was once lightly wooded and covered in soil. At the end of the Stone Age, nearly 6,000 years ago, farmers arrived. The farmers left their animals grazing and this, along with natural weathering, stripped the soil of vegetation, leaving this rocky landscape behind. The whole area, with its rich liana and fauna, is heaven for geologists and botanists. It also has over 2,500 historical sites to keep you busy. Stop at the Cliffs of Moher, the most majestic cliffs in Ireland. Independent lunch.

We'll take the Shannon car ferry and continue to Killarney for hotel check-in. Dinner and overnight at our hotel in Killarney.

DAY 6 Friday, December 13: Muckross House | Killarney National Park

Irish breakfast at our hotel. Begin our day with Mass at St. Mary's Cathedral. After Mass, we'll drive through the Molls Gap and Ladies View, with superb views of Mac Gillycuddy's Reeks and the famous Lakes of Killarney. Continue to visit Muckross House & Gardens. Muckross is a magnificent Victorian mansion built in 1843 and one of Ireland's leading stately homes. Built on the shores of Muckross Lake, it is beautifully situated amidst the spectacular scenery of Killarney National Park. The elegantly furnished rooms portray the lifestyle of the landed gentry, while downstairs in the basement one can experience the working conditions of the servants employed in the house. The gardens of Muckross House are famed for their beauty worldwide. In particular they are noted for their collections of azaleas and rhododendrons. The extensive water garden, children's sunken garden, and outstanding rock garden, hewn out of natural limestone, are just some of the features to be discovered. Independent lunch.

Enjoy free time this afternoon in the Killarney with its quaint and colorful streetscapes. You might enjoy a visit to The Taproom, the birthplace of Killarney Brewing and Distilling Co. and hub of storytelling and innovation. Try a flight and be sure to include a tasting of "Christmas in Killarney." Dinner and overnight at our hotel in Killarney. (B,D)

DAY 7 Saturday, December 14: Blarney Castle | Waterford

Irish breakfast at our hotel. This morning, depart for County Cork to visit Blarney Castle, where you will feel compelled to kiss the Blarney Stone and gain the gift of eloquence, or as an 18th century French consul put it, to "gain the privilege of telling lies for seven years." The castle itself, a tower house, dates from 1446 and is built on solid limestone. Stop for shopping at Blarney Woolen Mills, which sells high quality Irish crafts. Independent lunch.

Continue to Waterford, the oldest city in Ireland. A walled city of Viking origin, it retains much of its medieval character together with the graceful buildings from its 18th century expansion. Upon arrival, celebrate Mass at the Cathedral of the Most Holy Trinity in Waterford. After Mass, visit the world-famous House of Waterford, where we will see the masters at work! Visitors are guided through the different stages of production from the mold room to the blowing department, on to quality inspection, hand marking, cutting, sculpting, and engraving. Continue to our hotel to check in. Independent dinner and time to enjoy the Waterford Christmas Market. Overnight at our hotel in Waterford (B)

DAY 8 Sunday, December 15: Kildare | Dublin

Irish breakfast at our hotel. This morning, we'll leave Waterford to visit Kildare. Kildare dates back to the fifth century, when St. Brigid founded a monastery here. We'll visit Kildare's historic buildings, including the castle of the Earls of Kildare; the black, white, and grey abbey; a thirteenth century cathedral of St. Brigid; and a ninth century round tower. Celebrate Mass at St. Brigid's Catholic Church. Independent lunch.

We'll continue to Dublin for hotel check-in. Dinner and overnight at our hotel in Dublin.

DAY 9 Monday, December 16: Dublin | Farewell Dinner

Irish breakfast at our hotel. Celebrate Mass at Our Lady of Lourdes Church and the Shrine of Venerable Matt Talbott. After Mass, we'll have a panormaic tour of Dublin's "Fair City!" Then, we'll visit Trinity College to view the 8th century illustrated manuscript, The Book of Kells, followed by a visit to St. Patrick's Cathedral, made famous by its former dean, Jonathan Swift (Dean of St. Patrick's 1713-1745), author of Gulliver's Travels. The cathedral, built in 1213, is the largest in Ireland. This Gothic Cathedral, with a splendid interior, is adorned with funeral monuments, such as the Boyle Family Memorial and the grave of Dean Jonathan Swift. The Chancel has ornate stained-glass windows, some by Harry Clarke, which are magnificent features. Then we'll have a tour of the Guinness Storehouse to see how this famous brewery was established and how the popular black brew is created. Savour the sights, sounds, tastes, and aromas of Guinness. Independent lunch.

After lunch you'll have some free time to explore on Grafton Street. There is a wealth of unique and affordable shops in this area along with St. Stephen's Green Park and many museums and galleries.

This evening, enjoy dinner and entertainment at the Merry Ploughboy Pub. Their lively show features contemporary Irish dancing and well-known guest artists. Fine food is a very important element. At the Merry Ploughboy Pub, youthful vibrancy has successfully combined with traditional craftsmanship to provide excellent evening entertainment. (B,D)

Overnight at our hotel in Dublin.

DAY 10 <u>Tuesday, December 17: Return Home</u>

Irish breakfast at our hotel. After breakfast, we will be transferred by coach to Dublin Airport for our flight home. (B)
